Terms and Conditions

Program 3D Printed Part Sample Test Program.

Participants in the HP Deutschland GmbH Multi Jet Fusion 3D Printed Part Sample Test Program will be eligible to receive a 3D printed part sample printed with an HP Multi Jet Fusion according to the terms and conditions set out below to test the quality of 3D Printer Parts.

By participating, you accept these terms and conditions and the decisions of HP being final and binding in all respects.

Terms and conditions.

- 1.** You (herein after “participant” or “you”) must be 18 or older. Program is valid for business customers in Germany, only. This Program is not open to employees of HP, their agents, wholesalers, resellers, retail staff, retailers, participating logistic service providers or anyone connected with the Program.
- 2.** Limit one (1) 3D printed part sample per company or participant, while supplies last. Program is limited to the first one thousand (1,000) valid submissions. Not valid in connection with any other offer.
- 3.** To participate in the Program, you must complete the following steps:
 - a)** Follow the instructions to complete the Program registration form. Limit one (1) registration/request per company or participant. If HP Deutschland GmbH (“HP”) receives more than one request per company, only the first request received will be valid, the other requests will be rejected.
 - b)** On the Website of the Part Sample Test Program, follow the instructions to enter your contact information, choose one of the 3D printed part samples you would like to test and submit your request to get your 3D printed part sample printed on HP Multi Jet Fusion 3D Printers.
 - c)** Your 3D printed part sample will be delivered at the address in Germany you submitted with your Program registration form within five to ten working days. HP will not be liable if

3D printed part sample is delivered after this period.

d) 3D printed part sample will be printed with HP 3D High Reusability PA 12 material using the HP Jet Fusion 3D 4200 Printing Solution. Only available in black and without finishing/post-processing.

e) Participant may evaluate the 3D printed part sample for physical attributes (size, external smoothness, uniformity) required for their potential use. HP will conduct a phone survey with participants to collect your feedback on the 3D printer part sample you have tested (“feedback”). To that end, HP may contact you within 30 working days after shipment of the 3D printer part sample by phone or e-mail to collect your feedback on the 3D printer part sample tested. By accepting these terms you agree to be contacted within the scope of the Program.

3. HP reserves the right to disqualify incomplete, altered or illegible Program requests.

4. Restrictions/conditions may apply. Any attempt by any person or company to request more than one (1) 3D printed part sample using multiple company names, email addresses, mailing addresses, or any other fraudulent mechanism, as determined by HP in its sole discretion, shall give HP the right to deny the request

5. The decisions of HP in respect of any and all aspects of the Program test will be final and binding.

HP and its agencies are not responsible for lost, unintelligible, late, misdirected, incomplete, or non-delivered Program requests or emails; or for interrupted or unavailable satellite, network, server, Internet Service Provider or other connections, availability or accessibility of an Program Website, or miscommunications, or failed computer, satellite, telephone or cable transmissions, or lines, or technical failure or jumbled, garbled, corrupted, scrambled, delayed or misdirected transmissions, or computer hardware or software or Website malfunctions, failures, or technical errors or difficulties, or other errors of any kind whether human, mechanical, electronic or network or the incorrect or inaccurate capture of a participant’s request or the failure to capture, or loss of, any such information. HP and its agencies are not responsible for any incorrect or inaccurate information, caused by any equipment or programming associated with or utilized in this Program; and assume no responsibility for any error, omission, interruption, deletion, defect or delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or tampering with or hacking of any Website or equipment used for this Program. HP reserves the right, at its sole discretion, to disqualify any individual it finds to be tampering with the Website, submission process or operation of the Program, to be acting in a non-sportsmanlike or disruptive manner, or with intent to threaten, abuse or harass any other person. MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, AND NON-INFRINGEMENT. HP SHALL NOT BE LIABLE FOR ANY LOSS, DAMAGE OR INJURY OF ANY NATURE HOWSOEVER CAUSED TO CUSTOMERS PURSUANT TO THIS PROGRAM. HOWEVER, NOTHING IN THESE TERMS SHALL EXCLUDE OR RESTRICT HP'S LIABILITY FOR DEATH OR PERSONAL INJURY OF PARTICIPANT PROVEN TO BE CAUSED BY HP'S NEGLIGENCE.

9. Participant assumes all risk relating to or arising from the 3D printed part sample provided under this 3d Printing Sample Test Program. HP or its Agents will have no responsibility for any loss or damage caused by the 3D printed part sample.

Participant agrees to be responsible for complying with all laws and regulations including, without limitation, laws and regulations applicable to import and export, such as the trade control laws of the United States and other national governments. Participant who exports, re-exports, or imports or otherwise transfers products, technology, or technical data assumes responsibility for complying with applicable laws and regulations and for obtaining required export and import authorizations. HP may suspend performance under this agreement i) if the Participant is in violation of applicable laws or regulations and ii) to the extent necessary to assure compliance under the U.S. or other applicable export or similar regulations.

11. Upon registration, participants will provide certain personal data to HP and its Agents for the purposes of this Program. The data will be transferred to HP's offices, and to its agents in Spain, to carry out this 3D Part Samples Test Program and for marketing and quality control analysis. HP and its Agents are responsible for storing, processing and transferring the participant's personal data. Any Personal Data you provide to us in connection with this Program will be dealt with by HP in accordance with the terms specified in the HP Privacy Statement (<http://www8.hp.com/us/en/privacy/privacy.html>).

12. Participant agrees that HP shall have all title and interest in any feedback for use in manufacture, sale, marketing and/or use of 3D HP Multi Jet Fusion 3D Printers or otherwise.

13. HP reserves the right to cancel or withdraw the Program at any time and for any reason without prior notice.

14. HP reserves the right to amend or cancel the terms of this Program at any time without notice.

15. This Program is subject to the laws of Germany. The courts of Stuttgart will have exclusive jurisdiction on any dispute related to the Program.

16. The 3D Printed Part Sample will be provided to Participants free of charge in the terms and conditions set out in this Terms and Conditions. The value of the 3D Printed Part provided to participants of this Program is approx. 15,-- Eur.
